"PROF. LUIGI TARTUFARI" PRIZE 2011 CALL FOR NOMINATIONS

The Accademia Nazionale dei Lincei has decided to award four "Prof. Luigi Tartufari" Prizes for italian or foreign scholars. The four Prizes, amounting to € 25.000 each (gross amount before taxes or any deduction).

To contribute to the celebrations of the 150th anniversary of Italian unification, the Accademia Nazionale dei Lincei shall allocate four Prizes – which in 2011 will involve the class of Moral, Historical and Philological Sciences – to scholars that have, through scientific rigorousness, contributed to the analysis and understanding of the national unification process in one of the following disciplines:

- Literature, Poetry, Art
- History and Philosophy
- Institutional and Socio-Economic Sciences
- Portrayal of Italy in the world

Candidates may be proposed or may apply personally.

The President of "Accademia Nazionale dei Lincei" invites the Members of the Academy and the Presidents of Italian and foreign Academies to nominate individual italian or foreign researchers.

Members of the Academy may not compete for the Prize.

Such nominations, including exhaustive motivations, must reach the Academy no later than 31st December 2010.

The applications for admission to the competition, on a plain sheet of paper, addressed to the Secretariat of the Accademia Nazionale dei Lincei – Via della Lungara, 10 – 00165 Roma – within 31st December 2010 (date of postmark), together with the followings:

- a) one copy of published works or manuscripts, preferably in electronic format (pdf). Manuscripts must be signed by the authors and be clearly legible;
- b) a brief report of scientific work;
- c) list of works submitted above (a) containing the title, publisher and year of publication of each work.

In his/her application the candidate must clearly indicate, under his/her responsibility, personal data.

Applications or works carried out in the offices of the Academy will not be accepted.

Examination of the proposals and applications for each prize shall be carried out by an *ad hoc* Committee appointed by the appropriate Class during the month of January 2011.

Members of the Academy who have submitted proposals may not be members of the Committee.

Should there not be any proposals or any applications, the Committee may not award the Prize.

Each Committee will be composed of five members, of whom at least three must be members of the Academy; additional members shall also be appointed by the appropriate Class.

Each Committee will elect its own President and Secretary and will fix the order and the procedure of the selection process.

The Committees must present to the Council of the Academy, no later than 31st May, the papers with their proposals from which it must be clear that all the proposed candidates have been given proper consideration.

The Council will then submit these proposals, with their own opinions, to the judgement of the appropriate Class and successively to the decision of the whole Academy in a Plenary Session.

The Prizes will be awarded during the closing ceremony of the academic year in June 2011.
